### Re: ADR Chambers as Office of the Integrity Commissioner - Year-End Report

Dear Ms. Pettit:

Thank you for the opportunity to act as the Office of the Integrity Commissioner ("OIC") for the City of Markham (the "City") over the past year. As you know, the OIC's role is to help Members of Council ("Members") ensure that they are performing their functions in accordance with their Code of Conduct (the "Code"). The OIC is available to educate and provide advice to Members on matters governing their ethical behavior. It is also responsible for receiving, assessing, and investigating appropriate complaints made by Council, Members, and members of the public respecting alleged breaches of the Code by Members.

We are hereby providing our Annual Report for the seventh operating year of the OIC covering the period July 1, 2019 to June 30, 2020.

### Code of Conduct Complaints

The OIC received one new complaint during the year. One investigation was concluded and no investigations were outstanding at the time we concluded this year-end report.

Investigator Marvin J. Huberman concluded that there were no contraventions of the Council Code of Conduct for the one complaint, and he provided a report dismissing the complaint with no further recommendations.

## **Requests for Advice**

There were five requests for advice. One of the requests for advice was from the City and four requests for advice were from Councillors.

## **Other Services**

During this reporting period, ADR Chambers fulfilled an additional service after being asked by a councillor to determine whether a claim for indemnification was covered under Article 3.6 of the City's By-Law 2019-42 (A By-Law to Provide for the Indemnification and Defence of Employees and Members of Council Against Loss or Liability in Certain Circumstances Arising Out of Acts or Omissions Done While Acting on Behalf of the Corporation).

#### **Suggestions**

We suggested, in our year-end 2019 report, the introduction of a Consent and Confidentiality Agreement ("CCA"). Complainants would be required to sign and return the CCA to us before the review of the complaint begins. The 90-day timeframe for completion does not begin to run until the Complainant returns an executed copy of this Agreement. The CCA helps to safeguard the integrity of the process of the IC. We continue to recommend the CCA.

We suggest the introduction of a Request for Advice Form to be made available to Councillors seeking advice from the IC. When completing this form, Councillors will outline the matter at issue and will be asked to provide sufficient detail to allow the IC to provide a complete response. We would be happy to provide you with a sample form.

## **Billings**

A summary of billing for the year is included in this report as Appendix 1.

#### Final Comments

It has been a pleasure to assist the City and its Members in contending with the issues which have arisen in connection with the administration of its Code of Conduct. We look forward to continuing to provide the services of Integrity Commissioner to the City in the forthcoming year.
